

## WINTER SWEEPSTAKES

### OFFICIAL RULES

1. **NO PURCHASE NECESSARY TO ENTER OR WIN.** Purchase will not increase your chances of winning. Void where prohibited. Restrictions apply.

2. **HOW TO ENTER:** Beginning on November 19, 2024 at 12:01am EST and ending on January 31, 2025, at 11:59 pm (the “**Promotion Period**”), fill in the online entry form to request a complimentary home inspection at [www.winLPC.com](http://www.winLPC.com). Your request must be received during the Promotion Period. Fill in all required information on the online entry form. The complimentary home inspection must be completed by February 14, 2025. One entry per person is permitted. Use of any robotic, automatic, programmed, or similar entry method or entering more than the number of times permitted will void all entries and result in disqualification. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules.
